Inquisition process steps

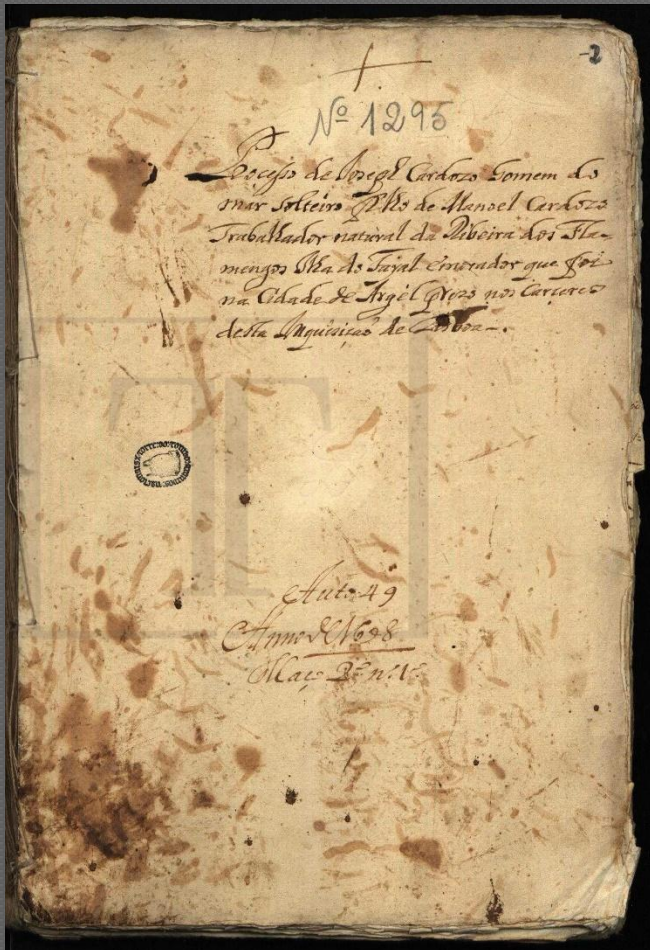
- 1st session: confession;

- privateering; travels; circumstances of return;
- Inquisition process; verdict.

 - Resisted muslim conversion for 9 years;
